As a participant of the 2nd ANOC World Beach Games Bali2023 ("AWBG Bali2023"), I acknowledge and agree that my participation in AWBG BALI2023 is conditional upon my acceptance of and my compliance with all the provisions of this AWBG Bali2023 Conditions of Participation Form and related rules referred to herein, which have been determined by the Association of National Olympic Committees ("ANOC") and the AWBG Bali2023 Local Organizing Committee.

For participants who are minors (under the age of 18) at the time of signing of this document, their participation in the AWBG Bali2023 is further conditional upon the participant's parents or legal guardian authorizing the minor participant's participation and confirming their agreement with all of the provisions of this Conditions of Participation Form, including without limitation the consent granted hereunder by the minor participant, through their signature of the Parent/Legal Guardian Acknowledgement of Consent for Minors.

- 1. Capture and Use of Images: participants may be filmed and photographed, during AWBG Bali2023.** Understanding that as a participant at the AWBG BALI2023, in consideration of the acceptance of my participation therein, I agree to be filmed, televised, photographed, identified and/or otherwise recorded during the AWBG Bali2023, and that my captured or recorded images, together with my name, likeness, voice, performance and biographical information, may be used in any content, format and through any media or technology whether now existing or created in the future, by ANOC and third parties authorized by ANOC during and after the ANOC World Beach Games in perpetuity in relation to the celebration and promotion of the ANOC World Beach Games ("AWBG"), the Sports Movement and ANOC in a commercial or non-commercial manner, including the creation of digital ANOC World Beach Games memorabilia or NFTs (non-fungible tokens).
- 2. Processing of personal information: AWBG Bali2023 Local Organizing Committee, ANOC and the host country, host state, and host city may require access to certain information, in particular to ensure the security at the Games, manage accreditations, competitions and results, carry out anti-doping activities, prevent manipulation of competition results, and provide services for the participants and the media.** I agree to personal information about me (personal data) being collected for the AWBG Bali2023 being used and stored in any place required for the Games operations, for the purpose of facilitating my participation in, and/or organizing AWBG Bali2023. This consent includes in particular the right for ANOC to collect and process my personal data, including when necessary, share such data with the host country, host state, and host city law enforcement authorities, the World Anti-Doping Organization, the Court of Arbitration for Sport and other third parties, in all manners and for the duration necessary for the following purposes:
  - a. Security risk assessments and other verifications to be carried out by the host country, host state, and host city authorities in order to grant accreditation for the AWBG Bali2023;
  - b. Investigation and/or prosecution of breaches of any provisions referred to in paragraph 3;
  - c. Statistics, historical studies and other research projects conducted during and after AWBG Bali2023; and
  - d. Any other data processing operation to which I provide my express consent to AWBG Bali2023 Local Organizing Committee.

I have taken note that I can contact ANOC in order to exercise my right to request access, rectification or deletion of my, or the participant's, personal information.

- 3. Compliance with the provisions of the Regulations of the ANOC World Beach Games and other rules: participating in AWBG Bali2023 is subject to the compliance with the fundamental rules governing the Olympic Movement, which aim to ensure the integrity of AWBG Bali2023 and the protection of clean athletes. The provisions of the ANOC Bye-law Regulating the celebration and conduct of the ANOC World Beach Games apply (herein referred to as the "Regulations of the ANOC World Beach Games") to the AWBG Bali2023. These provisions include, without limitation, Section IV (Eligibility of Athletes to Participate in the World Beach Games), Section V (Entries of the Participants in the ANOC World Beach Games), Section XI (World Anti-Doping Code and the Prevention of the Manipulation of Competitions and the ANOC World Beach Games), Section XIX (Advertisements and Publicity During the ANOC World Beach Games), Section XX (Coverage and Communication Materials of and for the ANOC World Beach Games), and Section XXI (Disciplinary Rules).**

I confirm that I have full knowledge of the provisions applicable to my participation at AWBG Bali2023 and that I agree to comply with all the rules and responsibilities applicable to my participation at AWBG Bali2023, in particular those arising from the following:

- a. The provisions of the Regulations of the ANOC World Beach Games and, in particular, the provisions regarding Eligibility to participate in Games (Section IV) and the prohibition against any kind of demonstration or propaganda at a venue or other AWBG Bali2023 site and publicity on persons or on clothing and equipment worn or used at the Games (Section XIX);
- b. The World Anti-doping Code, as well as the 2021 ANOC Anti-Doping Rules;
- c. The Olympic Movement Code on the Manipulation of Competitions;
- d. The ANOC Code of Ethics.

I confirm that the above referred texts and all the rules, and responsibilities applicable to my participation at the AWBG Bali2023, have been brought to my attention by my National Olympic Committee.



4. **Acknowledgement and acceptance of risks while participating at AWBG Bali2023: participation may imply exposure to certain risks (i.e. injury, loss of property, death), which despite all care taken by ANOC and AWBG Bali2023 Local Organizing Committee may not be completely eliminated.**

I agree to participate in the AWBG Bali2023 at my own risk; that I will take all reasonable measures to protect myself from the risks of participation; that I am responsible for all property I bring into the AWBG Bali2023 sites and that AWBG Bali2023 Local Organizing and ANOC shall have no responsibility for any loss or damage to this property. To the fullest extent allowable under applicable laws, I irrevocably release AWBG Bali2023 Local Organizing Committee and ANOC (and their respective members, directors, officers, employees, volunteers, contractors or agents) from any liability for any loss, injury or damage that I may suffer in relation to my participation in the AWBG Bali2023, including death.

5. **Arbitration: the Court of Arbitration for Sport is exclusively competent to finally settle all disputes arising in connection with my participation in the AWBG Bali2023, which have not been resolved by sports governing bodies.**

I agree that any dispute or claim arising in connection with my participation at the AWBG Bali2023, not resolved after exhaustion of the legal remedies established by my NOC, International Federation governing my sport, AWBG Bali2023 Local Organizing Committee and ANOC, shall be submitted exclusively to the Court of Arbitration for Sport (CAS) for final and binding arbitration in accordance with the Code of Sports-related Arbitration. The seat of arbitration shall be in Lausanne, Switzerland and the language of the procedure English. The decision of CAS is final, binding and non-appealable, subject to the appeal to the Swiss Federal Court. I hereby waive my right to institute any claim, arbitration or litigation, or seek any other form of relief, in any other court or tribunal.

6. **National Olympic Committee`s confirmation: the NOC hereby guarantees that all the relevant rules, including all those referred to above, have been brought to the attention of the participant and that the NOC has been authorized by the National Sports Federation concerned to sign this AWBG Bali2023 Conditions of Participation Form on the latter`s behalf, with the approval of the relevant International Federation.**
