Release and waiver: I irrevocably release ANOC and AWBG Bali2023 Local Organizing Committee (and their respective members, directors, officers, employees, volunteers, contractors or agents) from any liability (to the extent permitted by law) for any kind of loss, injury or damage that the participant may suffer or be exposed to in connection with the participant`s participation in the ANOC World Beach Games Bali2023.

Arbitration: I agree that any dispute, controversy, or claim arising out of or in connection with this Acknowledgement of Consent which cannot be settled amicably shall be submitted exclusively to the Court of Arbitration for Sport (CAS) in Lausanne, Switzerland, for final and binding arbitration in accordance with the Code for Sports-related Arbitration. The seat of arbitration shall be at Lausanne, Switzerland. The decision of CAS shall be final, binding and non-appealable. I shall not and hereby waive my right to institute any claim, arbitration or litigation, or seek any other form of relief, in any other court or tribunal.
