## Terms and Conditions

1. Training sessions are scheduled in SLOTS of 25 minutes of training and 5 minutes for boat changeover within different time windows. In the request form, you must indicate your preferred time window.
2. For each TIME WINDOW, a maximum of 16 bookings for 1x, 12 for 2x, and 4 for 4x will be available. Requests will be assigned in chronological order based on receipt of bank transfers. If slots are fully booked, an alternative slot will be arranged after registrations close.
3. The rental cost is €15.00 per seat (coxswain excluded) for any type of boat. The rental includes oars and safety equipment.
4. The rental will be confirmed only upon receipt of payment by bank transfer to IBAN: IT02T0623004616000015077790 (BIC: CRPPIT2PXXX). The payment reference must state: 'TRAINING RENTAL and CLUB NAME'. The organization will confirm the assigned SLOT following chronological order of receipt of request forms.
5. By signing this form, the applicant assumes full responsibility for any damage caused to rented boats and oars and agrees to reimburse repair or replacement costs upon request. At the sole discretion of Cantiere Filippi Lido srl, Canottieri Mondello asd, and CCR Lauria, an advance payment for repairs may be required depending on the extent of the damage.
6. Bookings must be submitted starting Tuesday, March 10 and no later than the registration deadline by sending this form via email to: canottierimondello@gmail.com.
